

## No Visa Required (NVR) - Application Requirement

- (1) Visa is valid for Travel to Bangladesh as long as the Foreign Passport remains valid on which it is affixed.
- (2) NVR VISA allows Multiple Entry to Bangladesh for Unlimited Stay Time.
- (3) Service FEE -\$50.00 (Fifty US Dollar): Money Order/Cashier's Check payable to "Embassy of Bangladesh".

### Required Documents:

#### **A. FOR BANGLADESHI AMERICAN (US PASSPORT HOLDER)**

1. One copy of duly filled-in Visa application form (FORM - D)
2. One passport-size color photo with white background (attach on top-left corner)
3. Original US passport (minimum 6-month validity) with ONE photocopy (Info page)
4. Copy of Bangladesh Passport (Valid or Expired). 1-5 page for Hand Written Passport.

OR copy of 17-digit Digital Birth Certificate

OR copy of Dual National Certificate

- OR copy of Bangladesh National ID Card AND copy of previous NVR along with copy of corresponding Foreign Passport
5. Copy of court order in case of a name change.

#### **B. CHILDREN OF BANGLADESHI / BANGLADESHI AMERICAN (BORN IN USA):**

1. One copy of duly filled-in Visa application form (FORM - D)
2. One passport-size color photo with white background (attach on top-left corner)
3. Original US passport (minimum 6-month validity) with ONE photocopy (Info page)
4. Copy of US Birth Certificate showing Parents' name;
5. Copy of Bangladesh passport of Father OR Mother (first five page);
6. Copy of court order in case of a name change.

#### **C. TRANSFER OF NVR (FROM OLD PASSPORT TO NEW PASSPORT):**

1. One copy of duly filled-in Visa application form (FORM - D)
2. One passport-size color photo with white background (attach on top-left corner)
3. Original CURRENT US passport (6-month validity) with ONE photocopy (Info page)
4. Original OLD expired US Passport with one photocopy each of the Passport and the Page with "No Visa Required"

In some cases - copy of Bangladeshi passport (existing/expired) may be required;

5. Copy of court order in case of a name change;

#### **D. FOREIGN SPOUSE OF BANGLADESHI/BANGLADESHI AMERICAN:**

1. One copy of duly filled-in Visa application form (FORM - D)
2. One passport-size color photo with white background (attach on top-left corner)
3. Original CURRENT US passport (6-month validity) with ONE photocopy (Info page)
4. Copy of Husband's/Wife's valid or expired Bangladesh passport (page 1-5)

OR Copy of His/her Dual Nationality Certificate

OR copy of National ID Card of Bangladesh;

5. Copy of Marriage Certificate;
6. Notarized affidavit/declaration by wife/husband stating their marriage is not broken.
7. Copy of court order in case of a name change.

## RE-ISSUE / RENEWAL OF MACHINE-READABLE PASSPORT (MRP)

### NOTE:

- A. If you are the **first-time applicant for MRP**, this page is **not applicable** for you.
- B. Must provide **e-mail address** on the application form for updates of the application
- C. Service Fee: **Regular - \$ 110**, Express - \$ 220 Money Order OR Cashier's Check
- D. **Old Passport** (MRP- Expired/Expiring) must be submitted with Application. Old MRP will be given back after verification.
- E. **Return Mailing Envelope**: Each Applicant must include a SEPARATE self-addressed return envelope with proper postage and tracking number of USPS Priority/Express Mail only - this is irrespective number of applicants from same Family/Address.

### Required Documents:

1. ONE Copy duly filled out Passport Re-issue Application Form (DIP Form - 1)
2. Attach Original Bangladeshi passport (Current passport) and one photocopy of Information Pages only;
3. Recent Passport size photo- 1 copy (Attach on the top left corner of the form);
4. For under 15 years old - must attach 1 Passport size Photo of both father and mother (Attach with glue on the top right corner of the form);
5. Copy of National Identification Card (NID)  
OR Bangladeshi digital Birth Registration Certificate with 17-digit
6. Copy of Proof of Valid Residency (valid Visa/Green Card etc.) in the USA.  
**US State ID or Driving License will not be considered as Proof of Valid Residency;**
7. U.S. Passport holder, must provide a copy of the **Bangladesh Dual National Certificate**
8. Marriage /Divorce Certificate (if applicant wants to add or change spouse name);
9. Service Fees - attached on top of the Application (As stated in the note above)
10. Include Return Mailing Envelope at stated in the note above.

## Attestation / Power of Attorney application Requirements:

NOTE: Applicant will need be personally present for service by the Mobile Team

### Required Documents:

1. Completed Application Form - C (1 page) for Attestation, 1 (one) copy
2. Two photographs of Principals and Two photographs of the Attorney are to be attached for verification by the Embassy.  
All Photographs must be passport size, color with white background, taken recently within the last six months.
3. Original Document and One photocopy of the original document
4. Proof of property ownership (Copy of mutation, succession/deed- RS, CS & BS)
5. Photocopies of the valid/expired Bangladesh Passport (1-7 pages)
6. Any US photo ID such as Driver's License
7. Copy of court order in case of name change.
8. Service FEE - \$ 82.50 (URGENT - one day): Money Order/Cashier's Check payable to Embassy of Bangladesh.

## DUAL NATIONAL CERTIFICATE APPLICATION REQUIREMENT:

NOTE: A. Use Date Format (day/month/year dd/mm/yyyy):

B. E-Mail Address must be provided in the Application - for updates on Application

C. Original Signatures needed on Pg. 2 - 5, photocopy of signature not allowed

### Required Documents:

#### 1. Completed FORM - 3 Sets

Pg. 1-2: General Information including - Education, Income & Remittance

Pg. 3: Declaration of Assets - Movable/Immovable (if any). Parents' asset can be given

Pg. 4: Statement of Activities in last 5 years

Pg. 5: Affidavit for Dual Nationality Certificate (DNC)

#### 2. Copy of foreign Passport

#### 3. Copy of Citizenship/Naturalization Certificate

4. Attach 4-copies of passport size color photographs taken within the last 6 (six) months with white background.

- a. Write applicant's name on the back of all the photos
- b. Staple two copies on the first set and one copy each on second and third set.
- c. Staple photo vertically on right hand corner of the Box (**DO NOT Use glue**)

5. Copy of Current/Expired Bangladesh Passport. Page 1-7 if PP is Hand Written.

#### 6. For Children born in the USA -

- a. Copy of Birth Certificate of the Child (Applicant)
- b. Copy of Parent's Bangladesh Passport. Page 1-7 if PP is hand written.  
OR Parents' Dual Citizenship Certificate

7. Service FEE - \$ 77 (Seventy-Seven) : Money Order/Cashier's Check payable to "Embassy of Bangladesh"

## TRAVEL PERMIT / DOCUMENT APPLICATION REQUIREMENTS:

### NOTE:

- A. Person to appear for consular interview
- B. E-Mail Address required - for update on Application

### Required Documents:

1. Duly filled-in the Application Form
2. Three color Passport photographs with white background taken recently  
ONE Photo attached on the Left and TWO Photos Stapled on the Right side of the form
3. Valid document in support of Bangladesh identity such as present passport;
